I want to correct some information that I gave regarding Jacob Poe's second wife, Sarah Brown Jenkins Batman Poe. I do not have documentation of her parents and did not realize that I had not corrected this. In fact I do not know if her maiden name was Brown or Jenkins. According to the ages listed for her in the census of 1850 - 1880 she was born between 1824 and 1832. If she was born at the earlier date it is possible that she could have married before her marriage to Alexander Batman in 1844 but I do not know.

Sarah was the widow of Alexander Batman, son of John Batman and Mary Brown. In the 1850 Census Sarah, Alexander, and son, Jeremiah, did live with Jeremiah Jenkins in Crawford Co, Whiskey run Township, IN.

However, I do have two pictures which relate to these families that were sent to me.

1.) first picture is of the Jeremiah Batman family. It was said to be circa 1900.

State of Indiana vs. Parker & Smith — Larceny.

Cause dropped.

State of Indiana vs. Julius Woodford — scire facias.

Sufficient excuse made to the Court for non-attendance as Petit juror at September Term 1820. The Defendant is discharged and exonerated.

State of Indiana vs. Haron Gott — Scire Facias.

The Court deeming the Defendant's excuse reasonable for non-attendance as a Petit juror at the September Term 1820, order the Defendant discharged.

NOW AT this day came Peter Davidson into Court and acknowledged himself indebted to the State of Indiana for the use of Crawford County to be rendered in the sum of one hundred dollars and at the same time came Jacob Froman and Martin Followell and severally acknowledged themselves indebted to the State of Indiana for the use of Crawford County to be rendered in the sum of fifty dollars each to be levied of their respective goods, chattels, lands and tenements if default be made on the condition under written which is that the above bound Peter Davidson shall personally appear before our Crawford Circuit Court on the first day of our next term and then and there answer what may be objected against him and from now until then to keep the peace towards all the good citizens of this state and more particularly towards Henry Barker and not depart said Court without leave, then this recognizance to be void, else to remain in full force and virtue in law.

Jeremiah Tartton vs. Stephen Robertson — Covenant.

On affidavit of Jno. N. Dunbar that the Plaintiff is not a resident of this state and on his motion a rule is entered against the Plaintiff to shew cause on or before the calling of the cause at next term why his suit shall not be dismissed for want of security for costs and this cause is ordered to be continued until next term.

ORDERED THAT Court adjourn until tomorrow

Tuesday, March 27, 1821

Court met pursuant to adjournment. Present as yesterday.

State of Indiana vs. William Wilkerson — Indictment for Stabbing.

This day came the Prosecuting Attorney and the Defendant being three times solemnly called came not, but made default, and on motion of his securities the recognizance for his appearance is quashed and this cause stands continued until next term and an *alias capias* is awarded to the Sheriff of Perry County with directions to take security of the Defendant in the sum of one hundred dollars with one or more good and lawful men in the like sum of one hundred dollars.

State of Indiana vs. William Teague — Jail Breaking.

This day came the Prosecuting Attorney and the Defendant although three times solemnly called came not, but made default and this cause stands continued until next term and it being three times demanded of Harban Moore, the security in the recognizance for his appearance to produce the body of the said William Teague and he failing so to do — It is ordered that a *scire facias* issue against the said Moore to shew cause why judgement and execution should not be had against him.

State of Indiana vs. Michael Hervey — Assault & Battery.

On motion of the Prosecuting Attorney this cause stands continued until next term and attachments are ordered against Michael Hervey Jr. of Crawford County and Lydia French of Orange County returnable to next term — And now at this time came the said Michael Hervey Jr. and William Graves and severally ac-

knowledged themselves indebted to the State of Indiana for the use of Crawford County to be rendered in the sum of fifty dollars each to be levied of their respective goods, chattels, lands and tenements if default be made on the condition under written which is that the said Michael Hervey Jr., above bound, shall personally appear here on the first day of the next term of the Crawford Circuit Court and answer to an indictment now pending against him for Assault & Battery and not depart said Court without leave, then this recognizance to be void, else to remain in full force and virtue in law.

State of Indiana vs. Wesley Jones — Assault & Battery.

Continued to next term and *scire facias* issued against Defendant Henry Jones; his security is dismissed.

State of Indiana vs. William Teague, Samuel Parker & John Smith — Jail Breaking.

On this day came the Prosecuting Attorney and says he will no further prosecute the above cause.

State of Indiana vs. Charles Ridge — scire facias.

At this time a satisfactory excuse having been rendered for the non-attendance as a juror at last term, he is discharged.

State of Indiana vs. John Hember — scire facias.

At this time a satisfactory excuse having been rendered for the non-attendance as a juror at last term, he is discharged.

John Jones vs. William Ammon — Debt.

Now at this time came as well the Plaintiff by his attorney as the Defendant in his proper person and the said Defendant says nothing of the Plaintiff action, but confessed a judgement for the sum of eighty seven dollars and eighty three and three-fourths cents with interest from the twenty-first day of December 1819 until paid. It is therefore considered by the Court that the Plaintiff recover against the said Defendant the said sum of the debt with eight dollars thirty three cents in damages, making in all the sum of ninety six dollars sixteen and three-fourth cents together with his costs and charges by him about this suit in his behalf expended.

Elizabeth Andrew vs. Thomas Andrew — Libel for Divorce.

This day came the Plaintiff by her attorney and this cause is continued until next term and it appearing to the satisfaction of the Court that the Defendant is not a resident of this state, it is ordered that notice of the pendency of this libel be published in the Indiana Gazette
