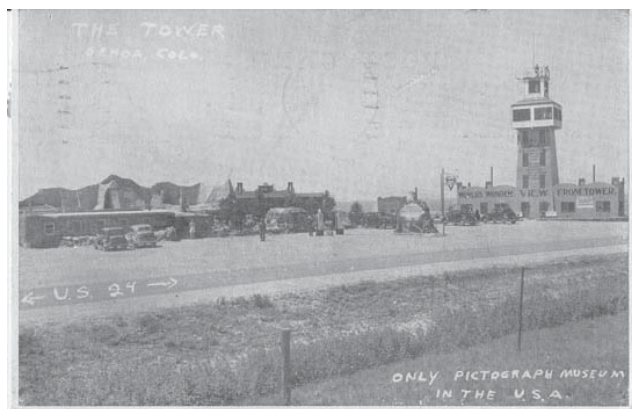

## Crawford Co. Native Constructed Colorado Landmark

Wonder Tower in Genoa, Colorado  
(from un-named newspaper)



This view looking southwest is from what remains of abandoned Hwy 24 - some of the asphalt still exists. I-70 is on the opposite side of the tower.



From a mile away the Wonder Tower appears to be bustling. "See Six States!" yell the hand-painted signs. "Confirmed by Ripley!" One sees cars in the parking lot, and people at the top of the Tower, trying to see the advertised six states.

Once you arrive, you realize that the parked cars are 40 years old and stuffed with sun-bleached bottles, their tires buried six inches deep in windblown prairie dust. The people in the Tower are crude fakes - lumps of red sheets wearing sunglasses.

## MORE: Charles Gregory

The Wonder Tower, built in 1926 at the highest point between New York and Denver, was a major stop. Charles W. Gregory, Colorado's P.T. Barnum, would stand on the Tower and spot license plates of approaching cars. When tourists were within earshot, he would boom appropriate greetings through a megaphone. "How're things in the Buckeye State?" His billboard motto was Eat, drink, gas and pop at the Tower.

Then the interstates came. C.W. died. The owners for the past 20 years, Jerry and Ester Chubbuck, have kept the Tower alive charging one dollar for admission. Small signs at the entrance promise "Animal Monstrosities," and "Two-headed calf."



## CHARLES GREGORY DIES THURSDAY AT DENVER

*Sherman County Herald, Goodland, Kansas, July 15, 1943*

The many friends of Charles Gregory were very sorry to learn of his death last Thursday in a Denver hospital where he had been taken for medical treatment several days previously.

Mr. Gregory was a well-known character through western Kansas and eastern Colorado, where he had spent the greater part of his life. Coming to western Kansas as a young man, he gave many years of his life to the upbuilding of this section which he always had called "home."

"Charley," for as such he was known to his many friends, spent several years in business in Goodland where he enjoyed many staunch friendships. He was

an active member of the Methodist church and a most earnest worker in the cause. From Goodland he moved to Genoa, Colo., where he erected the "Tower" which is widely known to the traveling public and has attracted nationwide attention. Here he also erected one of the finest lunch rooms "along the trail," as well as a museum of some note which featured many articles of interest to this section as well as crop displays and other items; "The Tower" and other buildings will stand through the ages as a monument to his untiring efforts to improve his holdings and advise the world of the many possibilities of the west.

Mr. Gregory came to Goodland about 1900 and found employment with the Rock Island water service, later went into the shops as a tinner, then fireman

of the shop boilers, to locomotive fireman and engineer. He was a member of the B. of L. E. and in good standing when he resigned his position sometime about 1916 to engage in the plumbing business with Hottel & Williams. Later he and George Johns opened a plumbing shop in the building now occupied by Freda's café, which was carried on for several years. He built what is now the Colony Club for a cabin camp, which later was sold and he moved to Genoa.

Charles W. Gregory was born in Salem, Ind., on July 27, 1876, [other sources, i.e. another newspaper obituary says Charles Gregory was born in Crawford County Indiana] the son of Caleb and Nancy [Brown]Gregory, and died in St. Luke's hospital, Denver, July 8, 1943, being of age, 66 years, 9 months and 11 days.

As a small child he came with his parents to western Kansas where he since has resided with the exception of the past several years spent at Genoa, Colo. On April 21, 1898, he was untied in marriage with Ethel Mae Kirk, who preceded him to the great beyond in December, 1926. To this union six children were born, of whom four survive: Bert, of Goodland; Lieut. Bob, who is a prisoner of war held by the Japanese in the Philippine islands; Mrs. Vera Rush and Miss Lola Gregory, both of Chula Vista, Cal. One daughter, May, passed away in infancy, and Verle answered the final summons in August, 1928.

He leaves also to mourn his passing, one brother, A. P. Gregory; eight grandchildren, one great grandchild, and several other relatives as well as a host of friends who have known and admired him for many years.

Funeral services were held from the Methodist church in Goodland Sunday afternoon at 2 o'clock, conducted by Rev. Basil Johnson and burial in Goodland cemetery. Music was by Rev. and Mrs. Johnson who sang: "I Love to Tell the Story" and "In the Garden," with Mrs. Pearl Baumgartner at the organ. Pallbearers were: Ed Newton, Fred Patrick, Dan Gilbert, Jay Morey, Arthur Kemp and Sanford Adams.

The first mention of the name of Gregory in the Crawford County Census is **in 1830** where we find Laben and Lloyd. **In the 1840** Census we find: Bry, Jesse, Laban, Lloyd and Minton. **In 1850** we find: Lloyd, Lucinda, James, John, Fanny, Benjamin, Lucinda, Fanna, Bry, Jessie, Susan, Elizabeth, John, Caleb, James L, Fanna, Wilson, Joseph, Mary, Marthey Ann, Laben, Hiram, Jacob, Louis, Luisa, Bry, Isabela, Lucinda, James, Lonatha, Angeline, Fanna. **In 1860** we find: Sarah, Martha, Caleb, Laban, Nancy, John M., James J., John, Milly, Louisa, Lucinda, Angeline, John C. Frans, William E., Arabell, Lucinda, John, Martha, Mary E. Jesse, Susan, Mary, Hiram B., James W., Cynthia Jane, Bry, Wilson Scott, Jane, Lucinda, Elizabeth, Martha Ann, Jacob R., Isabel, Lewis E. Letta J., Letta E., William B., Laban, Demia, James, Matilda, Hannah, Loyd, Lucinda, Thomas, Henry, Mary, Lucinda, James L.

**The parents of Charles Gregory** are Caleb and Nancy Winifred Brown Gregory, both listed in the 1860 census. They were married in Crawford County on Oct. 4, 1855 [Book B, Page 252]. According to Ancestry.com, Caleb was born 1833 and died 1911, while Nancy was born 1836 and died 1914, both died in Kansas.

**Parents of Caleb Gregory** were Jesse Gregory (born: 11 Jan 1812 in Smith, TN; died 12 Jan 1868 in English, Crawford County, IN) and Susan Nash (born: 15 Jan 1812 in Smith, TN; died 16 Oct 1887 in English, Crawford County, IN). They were married 28 March 1833 in Crawford County, IN.

**The parents of Jesse Gregory** were Laban Gregory (born: 1789 in NC; died 24 Jan 1849 in Crawford County, IN) and Sina Perkins (born: Bet 1790 and 1795 in TN; died 1827 in Smith County, TN) They were married in TN bet 1805 and 1808.

**The parents of Laban Gregory** were Benjamin "Bry" Gregory (born: May 1761; died 1 Jan 1846, prob in IN) and Christine E. Austin (born: after 1761; died before 1846 in TN). They were married about 1784.

**Parents of Benjamin "Bry" Gregory** were Thomas Gregory (1730-1818) and Susanna Benton (1729-1767. Both were from TN/NC.

Fredonia. October 28, 1823. Court met pursuant to adjournment. Present: James R. E. Goodlett, President and David Stewart, his Associate Justice.

#### Elijah Pope vs. Moses Smith & John Meylin — Debt.

The Sheriff having returned the process in this cause executed as Moses Smith and that John Meylin is no inhabitant of this county. Defendant appears and says he is not guilty as charged and for trial puts himself upon the county and the Prosecutor doth the like; and thereupon came Henry Conrad and acknowledged himself to owe and stand indebted to the State of Indiana in the sum of \$200 and at the same time came Joseph Tibbs acknowledged himself to owe and stand indebted to the State of Indiana to the use of the seminary of Crawford County to be rendered in the sum of \$100 to be levied of their respective goods and chattels, lands and tenements if default be made in this condition which is that if said Henry Conrad appear before the Court on the first day of our next March Term and answer to an indictment preferred against him and not depart without leave then this obligation to be void, else to remain in full effect and virtue in law.
