## Blinded by a Ghost.

From *The Hartford Herald* (Hartford, KY)

December 27, 1899.

A case of total blindness was reported by the physicians of English, Indiana. The case is one very much similar to one reported several weeks ago in the East.

Ernest Andrews, a sober, young man, is the victim, and his story that he was blinded by a ghost which he met on three or four occasions near Doolittle Mills, influenced his neighbors to the belief that the young man is insane; to his misfortune Mr. Andrews reports that while passing in front of an old dwelling, he was ----- by a huge flame, from which issued a voice, telling him to pay a debt of more than \$1,000 contracted by his uncle, now dead, or he would die by fire. The uncle died several years ago, and Ernest's mother is now the only immediate relative. The young man at first accepted the vision as a prank of some of the uncle's creditors, and he was told by his mother, now a widow, to pay no heed to the demands. Ernest is now blind and he is giving the matter serious thought.

On the third day of October in the year 1832 personally appeared in open court before the judges of the Crawford Circuit Court now sitting, Samuel Chapin, a resident of the county and state aforesaid, age 72 years, who being first duly sworn according to law doth on his oath make the following Declaration in order to obtain the benefits of the Act of Congress passed June 7, 1832. That he enlisted in the service of the United States under the following named officers and served as hereinafter stated; That is to say that he was first sent in the company to guard ammunition from Bennington in Vermont to the North River in the State of New York; Does not recollect who commanded the guard, was in the service at that time five or more days; The second time he was called out under Captain Samuel Robinson, commanded by Colonel Moses Robinson of Bennington, VT, marched to Ticonderoga and was in service about one month, then was discharged by Colonel Robinson, but received no written discharge. Thirdly, he enlisted into the Rangers for six months under Captain Parmalee Allen, commanded by Colonel Samuel Herrick, served the same and was discharged by Col. Herrick, but received no written discharge, after that was called out to go to Castleton, he does not recollect his Captain, but Samuel Herrick was the Colonel who commanded, served
